WAYS TO GIVE NOW

IRA CHARITABLE ROLLOVER

70 ½ and older can transfer up to \$100,000 directly from their IRA to ATJC tax-free. If you are 72 or older, this gift can also satisfy your required minimum distribution.

A GIFT OF APPRECIATED STOCKS

Donating appreciated stock is a tax-smart way to support ATJC's holy work. You will receive an immediate income tax-deduction based on the fair market value of the securities and avoid paying capital gains tax (if held for more than one year)

GIFT OF CASH

By making a cash gift, you'll see your generosity in action, and when you itemize, you'll receive a federal income tax Charitable deduction. Cash gifts can also be given in tribute of a loved one.

DONOR ADVISED FUNDS

Through a donor advised fund, you have the flexibility to recommend how much and how often funds are granted to ATJC.

While not a legal document, your Declaration of Intent indicates your heartfelt promise that your will or estate plan will include instructions to provide for the support and future of ATJC.
